ASSIGNMENT OF PATENT RIGHTS

THIS ASSIGNMENT OF PATENT RIGHTS (this "**Assignment**") is made as of November 15, 2004.

WHEREAS, Power-One, Inc., a Delaware corporation ("**Assignor**") is the owner of the patents (including issued and applications therefor) described on Schedule 1 (collectively, the "**Patents**").

WHEREAS, Assignor desires to grant, convey, sell, assign, transfer and deliver to HC Power, Inc., a California corporation (the "**Assignee**"), and the Assignee desires to accept from Assignor, all of Assignor's right, title and interest in and to the Patents, according to the terms and subject to the conditions of this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees, intending to be legally bound, as follows:

1. Assignor hereby irrevocably grants, conveys, sells, assigns, transfers and delivers to Assignee all of Assignor's right, title and interest in, for all countries, (i) the Patents and any and all other patents of the United States and foreign countries which may be issued for the inventions covered by the Patents (the "**Inventions**"), (ii) the right to apply in foreign countries or any other jurisdiction for patents on the Inventions, (iii) any currently pending registrations or applications related to the Patents and the Inventions, (iv) any reissue or reissues, continuations, continuations in part and divisions of any of the foregoing, and (v) all claims for damages and equitable relief by reason of past infringement of the Patents, with the right to sue for and collect the same for its own account.
2. Assignor and Assignee shall execute and deliver, or cause to be executed and delivered, from time to time hereafter, upon request, all such further documents and instruments and shall do and perform all such acts as may be reasonably necessary or reasonably desirable to give full effect to the intent of this Assignment and to properly vest title to the transferred assets in Assignee, its successors, assigns or nominees.
3. Assignor authorizes and requests the Commissioner of Patents and Trademarks to recognize this Assignment of the aforesaid Patents of the United States to Assignee, and Assignor hereby consents that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the said Assignee to claim the aforesaid benefit of the right of priority provided by any international convention or treaty.

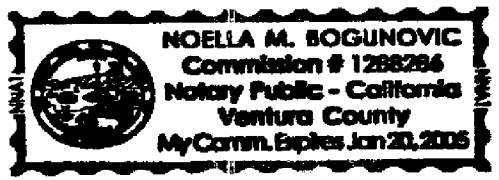

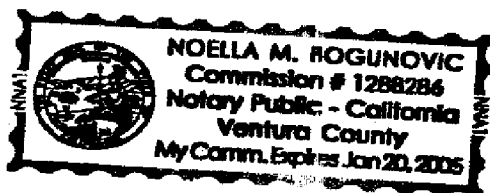
