
# ASSIGNMENT



Therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, we have sold, assigned, transferred and set over, and do hereby sell, assign, transfer and set over, to Assignee the entire right, title and interest in and to the Improvements and the Applications and all divisions, substitutions, continuations and continuations in part thereof, and all United States Letters Patent which may be granted thereon and all reissues and extensions thereof, and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patent (including related rights such as utility-model registrations, inventor's certificates, and the like) whether filed before or after this Assignment for the Improvements in any foreign countries, and all patents (including all extensions, renewals and reissues thereof) granted for the Improvements in any foreign countries; and we hereby authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications described above, to issue all patents for the Improvements to Assignee in accordance with the terms of this Assignment.

We covenant and agree that: (a) we have full right to convey the entire right, title and interest assigned under this Assignment, and that we have not executed, and will not execute, any agreement in conflict with this Assignment; and (b) we will promptly communicate to Assignee any facts known to us related to the Improvements, and testify in any legal proceedings, sign all lawful papers, execute all applications and divisional, continuation, continuations in part, substitute and reissue applications, make all rightful oaths and generally to everything possible to aid Assignee to obtain and enforce proper patent protection for the Improvements in all countries.


