

1. They are the President and the Secretary, respectively, of **RENAISSANCE NETWORK TECHNOLOGY CORPORATION**, a California corporation (the "Corporation").
2. Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

"ARTICLE I.

The name of this Corporation is **CRYSTALVOICE COMMUNICATIONS, INC."**

3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of articles of incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The total number of shares of capital stock of the Company entitled to vote with respect to the foregoing amendment of these Articles of Incorporation was 2,893,917 shares of Common, 1,467,787 shares of Preferred (Series A), and 1,575,000 shares of Preferred (Series B). The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of all outstanding Common and Preferred shares, voting together as a single class.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.

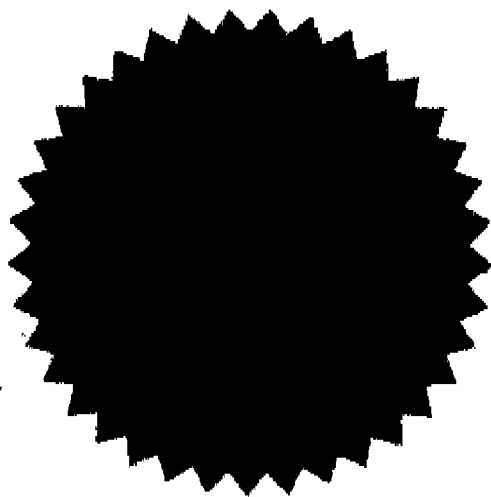
