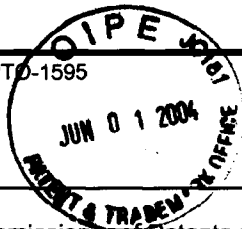



Assignment of Invention

WHEREAS, WE, **Alicia ROSO** of Chemin du Mercadel Bas, LONGUEGINESTE, 81710 SAIX, FRANCE; **Catherine BULCOURT** of 14, rue Rieux, 92100 BOULOGNE BILLANCOURT, FRANCE, **Nelly MICHEL** of 7, rue Raspail, 94700 MAISONS ALFORT, FRANCE respectively, have invented certain new and useful improvements in:

Mixture of self-invertible inverse latex and a powder for cosmetic or pharmaceutical use; use as texturizer

for which: (a) an application for Letters Patent was filed on February 6, 2004, having Application No. 10/774,268; or (b) for which an application for a United States patent was executed on _____, and




