AND, I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country of countries foreign to the United States, whose

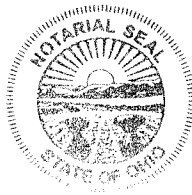

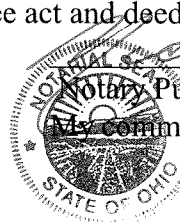
