ASSIGNMENT

WHEREAS, I, Wenming Yang, a citizen of the Republic of Singapore, have invented certain new and useful improvements in a "LOW PROFILE LOCK WITH FRONT RELEASE FOR A DRAWER SLIDE" for which I am about to make application for United States Letters Patent; and

I hereby further agree that I will communicate to said Assignee, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements, and, at the expense of said Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said Assignee and to aid said Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
