## ASSIGNMENT

This Assignment Agreement is entered into this twenty-fourth day of September 2003, between **CNH BELGIUM N.V.**, of Leon Claeystraat 3A, B-8210 Zedelgem, Belgium, **Marc R.M. JONCKHEERE** of Zomerweg 43, B-8490 Snelleghem, Belgium; and **Oldemar BOECK** of Rua Catarina Gabardo 520B, Xaxim, Curitiba, Parana, Brazil [hereinafter referred to as the **Assignors**] of the first Part and **NEW HOLLAND NORTH AMERICA, INC.**, a corporation duly organized and existing under and by virtue of the laws of the State of Delaware, having a place of business at New Holland, Pennsylvania, United States of America, [hereinafter referred to as the **Assignee**], its successors, and assigns, of the second Part.

WHEREAS, the said **Marc R.M. JONCKHEERE** is/has been in the employ of the said CNH Belgium N.V. within the jurisdiction of the Laws of Belgium and **Oldemar BOECK** is/has been in the employ of CNH Latino Americana Ltda within the jurisdiction of the Laws of Brazil, [hereinafter referred to as the **Inventors**] and the said **Marc R.M. JONCKHEERE** and **Oldemar BOECK** are the true and first Inventor(s) of an invention [hereinafter referred to as the **Invention**] entitled "**Utility machinery and associated reversible feeder mechanisms**", the application for United States patent describing said Invention being filed with the U.S. Patent and Trademark Office on May 30, 2003 under U.S. Serial No. 10/448,842 and the Convention Priority Claim based on British patent application number 02 12649.8, filed on June 19, 2002.

WHEREAS, by virtue of an Assignment dated 22 May, 2003, the **Inventors** and the said **CNH Latino Americana Ltda** have sold, assigned and transferred to the said **CNH BELGIUM N.V.** the entire right, title and interest in and to the Invention and in and to any patent application and patent granted thereon filed in any country, and including all divisions, reissues, continuations, and extensions of any such patent application and of all corresponding right of priority resulting from the filing thereof.

AND WHEREAS, the said **CNH BELGIUM N.V.** is joining in the execution of the present Assignment Agreement to convey all right, title and interest in the Invention as described below and vested therein by virtue of the contract of employment with the Inventor(s) and by virtue of any other agreements or rights of law or equity.

NOW, THEREFORE, in consideration of one dollar and other good and valuable consideration, the receipt of which is hereby acknowledged, the Assignors hereby sell, assign, and transfer to the Assignee the entire right, title and interest in the country of the United States of America in and to the Invention and in and to any patent application and patent granted thereon filed in said country, and including all divisions, reissues, continuations, and extensions of any such patent application and of all corresponding right of priority resulting from the filing thereof, and authorize and request that any and all said patents be issued to said Assignee, or its successors and assigns. The Assignors covenant that they have full rights and power to enter into this Assignment Agreement and agree that they will communicate to the Assignee or its representative, all facts known to them respecting the Invention, whenever requested, and that they will testify or provide access to personnel to testify in any legal proceeding, and that they will sign all lawful papers, execute all division, continuation and reissue applications, and make all rightful oaths, and generally do everything possible to aid the Assignee, its successors, assigns, and nominees, to obtain and enforce proper patent protection for the Invention in said country.


