PATENT ASSIGNMENT

WHEREAS, I, Katherine Angus, a citizen of Great Britain, residing at 4 Stonecellar Cottages, High Usworth, Washington, Tyne & Wear, NE37 1NS, have made an invention which invention is claimed and described in an application for Letters Patent of the United States of America entitled "IMMOBILISED AFFINITY MEDIUM AND ITS USE IN SEPARATION", filed herewith; and

And I hereby authorize and request the Commissioner of Patent and Trademarks of the United States of America and respective Patent Office officials in any country foreign to the United States of America to issue said Letters Patent to MILLIPORE UK as the assignee of my entire right, title and interest in, to and under the same, and I hereby further authorize MILLIPORE UK to apply for Letters Patent in my name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Agreement, in any country foreign to the United States of America.

And I, do hereby agree for myself and for my heirs, executors and administrators to execute any lawful document and to testify as to any material fact or thing which MILLIPORE UK, its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title and interest in and to and the full enjoyment of said invention or any part thereof and any Letters Patent, the same to be done without any further consideration.
