4. The holder of one hundred (100) shares of Common Stock consented in writing to the adoption of the Amendment.

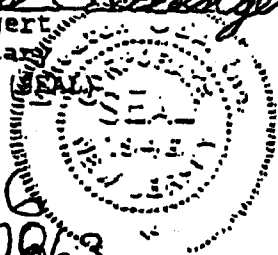
