THIS ASSIGNMENT, by Martin Warwick BEALE (hereinafter referred to as the assignor), residing in Bristol, Great Britain, witnesseth:

WHEREAS, said assignor has invented certain new and useful improvements in OBTAINING CHANNEL QUALITY INFORMATION IN A WIRELESS COMMUNICATION NETWORK, set forth in an application for Letters Patent of the United States, bearing Serial No. 10/922,584 and filed on August 19, 2004; and
