- (1) NASALEZE LIMITED a company incorporated in the Isle of Man with number O99463C whose registered office is at 8 Myrtle Street, Douglas, Isle Of Man IM1 1ED ("NL"); and
- (2) NASALEZE PATENTS LIMITED a company Incorporated in the Isle of Man with number 110818C whose registered office is at 6 The Shipyard, Ramsey Isle Of Man IM8 3DN ("NP")

#### WHEREAS:

- all the benefit of the Registered Intellectual Property including the benefit of the applications for registration with the intention that when the registrations are granted the registration will vest in NP together with the right to apply for similar protection in any other country, including the benefit of the priority date or dates and all right, title and interest in the same, together with all related rights and powers arising or accrued including the right to sue for damages and other remedies in respect of any infringement of all these assigned rights prior to the date of this agreement.

NL shall indemnify NP against all and any loss, damages or costs sustained by NP arising out of any breach by NL of any of its warranties under this agreement and, at the request of NP, it shall provide all reasonable assistance to enable NP to resist any claim, action or proceedings brought against NP as a consequence of that breach.

# 5. LAW AND JURISDICTION

The assignment shall be governed by and construed in accordance with the laws of England and the parties agree to submit to the non-exclusive jurisdiction of the English courts as regards any claim or matter arising in relation to this assignment. This assignment has been entered into on the date stated at the beginning of this document.


