## ASSIGNMENT

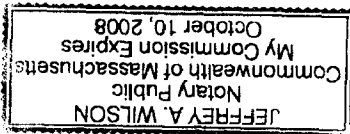

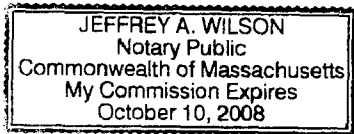

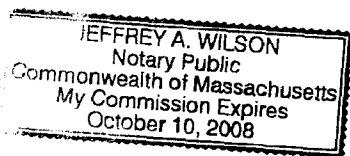
