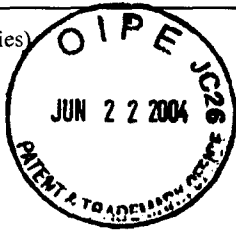

AND, I hereby further agree for myself and my executors and administrators to execute upon request any other lawful documents and likewise to perform any other




