


**Assignment of Invention**

WHEREAS, I, **Jean-Marc PEYRON** of 5 avenue de la Reine Blanche, 94000 CRETEIL has invented certain new and useful improvements in: **METHOD AND INSTALLATION FOR FEEDING AN AIR SEPARATION PLANT WITH A GAS TURBINE** for which: (a) an application for Letters Patent was filed on herewith, having Application No. \_\_\_\_\_; or (b) for which an application for a United States patent was executed on \_\_\_\_\_, and

We hereby authorize and request the Patent Office Officials in the United States and its territorial possessions, to issue any and all of said Letters Patent, when granted, to said ASSIGNEE as the assignee of our entire right, title and interest in and to the same, for the sole use and behoof of said ASSIGNEE, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by me had this Assignment and sale not been made.

Further, we agree that we will communicate to said ASSIGNEE or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.

The undersigned hereby grant(s) authorized representatives of the above identified ASSIGNEE(S) the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
