## ASSIGNMENT

I, Jyotindra K. And I further grant to THE SHERWIN-WILLIAMS COMPANY its successors and assigns, the right to claim for any of the aforesaid patent applications any privileges available under Conventions or other agreements relating to Industrial Property or under the municipal law in the countries in which said applications are filed.

And I hereby authorize and request the United States Commissioner of Patents, and appropriately empowered officials of foreign countries, to issue Letters Patent or Patents upon the aforesaid application or applications to THE SHERWIN-WILLIAMS COMPANY, aforesaid, its successors and assigns, as assignee of my entire right, title and interest in and to the same.
