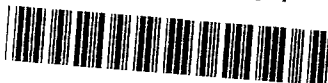



WHEREAS, I, ANDREW DOUGLAS BREDE, a citizen of the United States, residing at 14410 East 45<sup>th</sup> Court, Veradale, WA 99037, am the inventor of an invention in CREEPING BENTGRASS *AGROSTIS PALUSTRIS* (*STOLONIFERA*) VARIETY NAMED 'T-1' for which an application for Letters Patent is being filed even date herewith; and

R. SIMPLOT CO., its successors, legal representatives and assigns, in accordance with the terms of this instrument.
