RELEASE AND REASSIGNMENT OF PATENTS

THIS RELEASE AND REASSIGNMENT dated December 21, 2004 by Harris Trust and Savings Bank, as Agent as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, as agent for itself and the banks and other financial institutions entitled to the benefits of the security interests described in the Patent Collateral Agreement described below (the "*Secured Party*"), and MCGUANE INDUSTRIES, INC., a Michigan corporation with its mailing address at 24800 Denso Drive, Suite 255, Southfield, Michigan 48034 (the "*Debtor*") are parties to a certain Patent Collateral Agreement dated April 16, 2003 which was recorded in the United States Patent and Trademark Office on May 15, 2003 at Reel 014051, Frame 0623, pursuant to which the Debtor granted a security interest in and collateral assignment of certain patents listed on Schedule A attached hereto and certain other property (collectively the "*Patents*"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Patents and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:

(i) Each patent and patent application listed on Schedule A hereto and all of the inventions described and claimed therein and any and all reissues, continuations, continuations-in-part or extensions thereof; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any patent or patent applications listed on Schedule A hereto, in each case together with the right to sue for and collect said damages.
