AND, furthermore, I, Pu Zhou, covenant and agree with said SciMed Life Systems, Inc., its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.
