1. 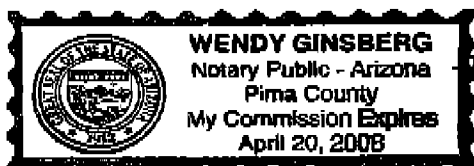
