

## **ASSIGNMENT**

WHEREAS, we, Helmuth GABL and Axel PICHLER, respectively residing at A-8046 Graz, Rannachstrasse 47, Austria; and A-8020 Graz, Grüne Gasse 51/2/9, Austria, have invented new and useful improvements in:

### **SCREEN AND PROCESS FOR MANUFACTURING A SCREEN OF THIS KIND**

for which we have made application for Letters Patent of the United States, which application was filed on April 9, 2004 under U.S. Serial No.10/821,831; and

WHEREAS, Andritz AG, an Austrian corporation, having a place of business at A-8045 Graz, Stattegger Strasse 18, Austria, is desirous of acquiring the entire right, title and interest in and to said improvements and any Letters Patent which may be granted thereon;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of the sum of One (1) Dollar to us in hand paid and other good and valuable consideration, receipt of which is hereby acknowledged, we, the said Helmuth GABL and Axel PICHLER, sell, assign and transfer to Andritz AG, its successors and assigns (hereinafter called "Assignee"), the entire right, title and interest in and to said improvements and in and to any Letters Patent which may be obtained thereon in the United States, together with said application and all divisional, continuing, substitute, renewal, reissue, and other applications for Letters Patent which have been or may be filed on said improvements in the United States, the same to be held and enjoyed by the Assignee for its and their sole use and behoof.


We hereby authorize and request the Commissioner of Patents and Trademarks to issue all Letters Patent of the United States on said improvements to the Assignee.


We further covenant and agree that when requested by the Assignee, and without further consideration, but at the cost and expense of the Assignee, we will execute and deliver all applications for patent on said improvements, execute all lawful oaths and other papers, supply to the Assignee all facts and evidence known to us relating to said improvements and the history and development thereof, testify in all interferences, suits, and other legal proceedings, and generally do everything rightful which the Assignee shall consider desirable for aiding in securing, maintaining, and enforcing proper patent protection for said improvements and for vesting the title to said improvements in the Assignee.

We further covenant that we have the lawful right to assign the interest in said improvements in the manner and form as herein expressed, that the interests herein conveyed are free from prior assignment, grant, mortgage, license, or other encumbrance whatsoever and that the execution of this Assignment is our own free act and deed.
