I agree that I will at all times keep said assignee advised of my whereabouts; and I will promptly, upon request of said assignee, and without further compensation, but at no out-of-pocket expense to myself, do all lawful acts, including the execution of all necessary documents and the giving of testimony that, in the opinion of the assignee, its successors and assigns, may be necessary or desirable for obtaining, sustaining, or reissuing United States and foreign Letters Patent relating to the foregoing assigned rights, and for perfecting, affirming, recording, and maintaining the title of said assignee, its successors and assigns thereto; and that I will generally cooperate to the fullest extent in all matters pertaining to said invention and patent and said assignee's title thereto.
