ASSIGNMENT OF RIGHTS

THIS ASSIGNMENT DEED is made the 31 of January Two Thousand and three

BETWEEN:

Gambro Dasco S.p.A., via Modenese 66, 41036 MEDOLLA, Italy (hereafter "ASSIGNOR")

AND

Gambro Lundia AB, Magistratsvägen 16, 22643 LUND, Sweden (hereafter "ASSIGNEE")

WHEREAS:

- 1) The ASSIGNOR has acquired or owns all or part of the intellectual property rights for "Support element integrated module for extracorporeal blood treatment comprising said support element, apparatus for extracorporeal blood treatment provided with said integrated module and assembling process of an integrated module for extracorporeal blood treatment", reference number PN0238(HF136) hereafter the "SOLUTION".

NOW THIS DEED WITNESSES that in consideration of the above premises and the sum of ten United States dollars and other good and valuable consideration, the receipt of which is hereby acknowledged, the ASSIGNOR hereby assigns, transfers and sets over unto the ASSIGNEE, its successors and assigns, all of its rights concerning the SOLUTION and in the INTELLECTUAL PROPERTY, included in particular all its rights to apply in respect of any national or regional patent application(s) or patent(s), priority rights, and other intellectual property right and all rights, privileges and advantages appertaining thereto to hold the same unto the ASSIGNEE, its successors and assigns absolutely.
