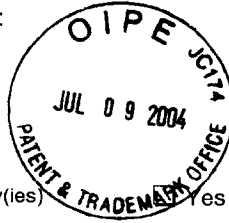

ASSIGNMENT OF INVENTION

WHEREAS We, Ilya Malyarov and Thomas Palmieri, have invented certain new and useful improvements in an invention entitled: **ROTARY LUMINOMETER**, for which a United States Patent Application has been allotted serial number 10/813,575 and was filed on March 31, 2004.

WHEREAS, DPC Cirrus, Inc., having a principal place of business in Flanders, New Jersey, hereinafter referred to as ASSIGNEE, is desirous of acquiring certain rights thereunder; and


