ASSIGNMENT

WHEREAS, I, among the following inventors, Max P. McDaniel, Elizabeth A. Benham, Steven J. Secora, Michael D. Jensen and Kathy S. And I do further covenant and agree that I will, at any time upon request, communicate to CPCHEM, its successors, assigns or other legal representatives, such facts relating to said Invention and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
