For valuable consideration of employment by General Electric Company, the receipt and adequacy of which are hereby acknowledged, and in fulfillment of our pre-existing obligation of assignment in connection with and pursuant to (i) that Research, Development and Distribution Agreement dated as of May 24, 2002, by and among GE Interlogix, Inc., a Delaware corporation ("GE Interlogix"); Broad Reach Technologies, LLC, a Delaware limited liability company ("Holdings LLC"); Broad Reach Security, LLC, a Delaware limited liability company ("Security LLC"); Broad Reach Video, LLC, a Delaware limited liability company ("Video LLC"); and exScientia, LLC, a Delaware limited liability company ("exScientia" and together with Holdings LLC, Security LLC, and Video LLC, the "Broad Reach Entities") and (ii) that Master Development and Option Agreement dated May 24, 2002 by and among the Broad Reach Entities and GE Interlogix, we, **John B.
