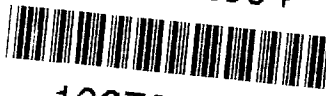

and foreign Letters Patent relating to the foregoing assigned rights, and for perfecting, affirming, recording, and maintaining the title of said assignee, its successors and assigns thereto; and that I will generally cooperate to the fullest extent in all matters pertaining to said invention and patent and said assignee's title thereto.
