RESOLVED, that Article I of the Certificate of Incorporation of REGENECOR HOLDINGS, INC. be amended to read as follows:

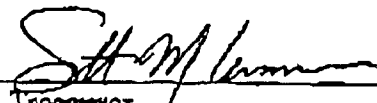
I: The name of the corporation is REVIVICOR HOLDINGS, INC.
