ASSIGNMENT AND AGREEMENT

WHEREAS, William D. Severa, Brian D. Dillman and Saud Khazal (hereinafter referred to as "ASSIGNOR") have co-invented a certain invention entitled HEAD PORTION OF A SPORTS RACQUET (Atty. Dkt. ASSIGNOR HEREBY AUTHORIZES AND REQUESTS the Commissioner of Patents and Trademarks to issue said Letters Patent to ASSIGNEE as assignee of the entire interest, for the sole use and benefit of ASSIGNEE, its successors and assigns.



inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.




