CHAIR WITH BACKREST DEPTH ADJUSTMENT MECHANISM

We hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said patents, when granted to said Kimball International, Inc., as the assignee of our entire right, title and interest in and to the same for the sole use and enjoyment of said Kimball International, Inc., its successors and assigns.

Further, we agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said Kimball International, Inc., its successors and assigns may require

to enable it or them to procure a Letters Patent on said invention or reissues or extensions thereof in the United States of America and/or in any foreign country, and/or to hold, enforce or convey said Letters Patent, reissues or extensions.
