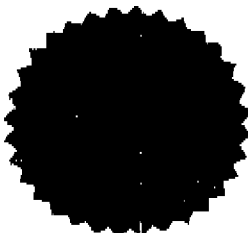

Pursuant to Section 18-209 of the Delaware General Corporation Law (the "DGCL"), Siemens Information and Communication Networks, Inc., a Delaware corporation ("SICN"), hereby certifies the following information relating to the merger of Siemens Information and Communication Mobile LLC, a Delaware limited liability company ("SICM") with the inco SICN (the "Merger").

1. The name and states of incorporation of each of the constituent corporation and limited liability company that are to merge in the Merger (the "Constituent Entities"), are:

4. The Certificate of Incorporation of SICN shall be the certificate of incorporation of the surviving corporation, except that such certificate of incorporation shall be, and hereby is, amended such that Article I thereof shall read in its entirety as follows:

"Article I. Name. The name of the corporation is Siemens Communications, Inc."

5. The executed Merger Agreement is on file at the offices of the surviving corporation at Siemens Information and Communication Networks, Inc., 900 Broken Sound Parkway, Boca Raton, Florida 33487.

6. A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder or member of either of the Constituent Entity.
