AND the said ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue United States Letters Patent for the said invention to the said ASSIGNEE for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which United States Letters Patent may be granted, as fully and entirely as the same would have been held by the said ASSIGNOR had this assignment and sale not been made;

I hereby undertake without liability at any time upon request to do everything legally possible to assist the said ASSIGNEE in the filing and prosecution of any patent application relating to the said invention in any country, to sign such documents and do such things as may be required to give effective legal and registered title of the said ASSIGNEE to the invention in any country, all without further consideration but at the expense of the said ASSIGNEE.


