ASSIGNMENT

WHEREAS, we JOSEF HUSMANN, a Swiss National, and ELENA CORTONA, an Italian National, residing respectively at Salzfassstrasse 6, CH-6006, Luzern, and Dorfstrasse 52, CH-8800, Thalwil, Switzerland, have invented certain new and useful improvements in an **Equipment For Vibration Damping Of A Lift Cage**, for which an application for Letters Patent of the United States of America is being executed concurrently herewith.

AND WE HEREBY further covenant and agree that we will communicate to the said business entity, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to said business entity, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in the United States, its territories and possessions.
