## ASSIGNMENT



I further agree, without any payment by Free University of Brussels (VUB), other than expenses incurred by the undersigned, to communicate to said Free University of Brussels (VUB), its representatives or agents, any fact relating to said inventions, inventions or improvements, including evidence for interference purposes or for other legal proceedings, whenever requested; testify in any interference or other legal proceedings, whenever requested; and execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective.
