It is understood that the foregoing covenants and agreements shall bind the legal representatives of the undersigned and inure to the benefit of the legal representatives, successors and assigns of the assignee.

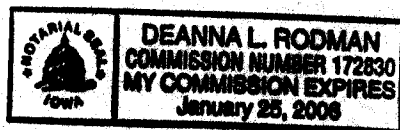
