(CEGASA)** to apply for Letters Patent in my name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Agreement, in any country foreign to the United States of America.

And I, do hereby agree for myself and for my heirs, executors and administrators to execute any lawful document and to testify as to any material fact or thing which CELAYA, EMPARANZA Y GALDOS, S.A. (CEGASA) its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title and interest in and to and the full enjoyment of said invention or any part thereof and any Letters Patent, the same to be done without any further consideration.
