ASSIGNMENT

WHEREAS, I, VINCENT LASTELLA, being a citizen of the United States, residing at 107 William Street, Clark, New Jersey 07066, hereinafter referred to as ASSIGNOR, have invented certain new and useful improvements in FECAL OCCULT BLOOD TESTING DEVICE AND METHODS for which I have executed an application for Letters Patent of the United States on even date herewith;

AND I HEREBY grant to James J. DeCarlo, Lawrence Rosenthal, Steven B. Pokotilow, Matthew W. Siegal, David L. Schaeffer and Ian G. DiBernardo, attorneys with the firm of STROOCK & STROOCK & LAVAN LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
