**COLLATERAL AGREEMENT
RE: PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES**

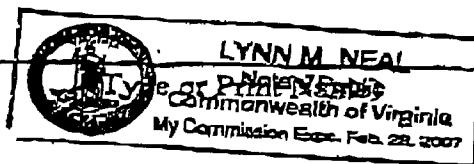
