NUNC PRO TUNC ASSIGNMENT

WHEREAS, I, Walter A. Newton, Jr., a United States of America citizen, residing at 3075 Dry Ponds Road, Granite Falls, North Carolina 28630, have invented certain new and useful improvements in a SURGICAL IRRIGATION/ASPIRATION SET-UP KIT for which I have executed an application for Letters Patent in the United States, filed on November 19, 1984, Application No. 06/674,064, which is now U.S. Letters Patent **4,900,302**, issued on **February 13, 1990**.


AND WHEREAS, ENTRAVISION, INC., a corporation of the state of North Carolina (hereinafter referred to as Assignee) desires to acquire the entire right, title, and interest in and to the said improvements and the said Application.

AND WHEREAS, this assignment is a retroactive assignment, effective as of March 1, 1992.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby acknowledges that it has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto Assignee, its successors, legal representatives and assigns, the entire right, title, and interest in the United States of America, and its territories and possessions in, to and under said improvements, and any Patent Applications in the United States of America and all divisionals, continuations, continuations-in-part (CPAs), and all Patents of the United States of America which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions; and Assignor hereby authorizes and requests the Commissioner of Patents of the United States of America to issue all Patents for said improvements to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR HEREBY covenants and agrees that it will communicate to Assignee, its successors, legal representatives and assigns, any facts known to it respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisionals, continuations, CPAs, and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in the United States of America.
