This document is being filed in order to clarify the chain of title for this matter.

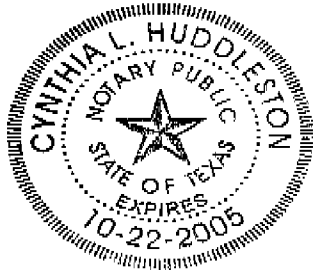

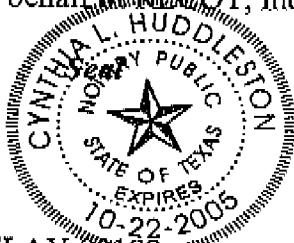

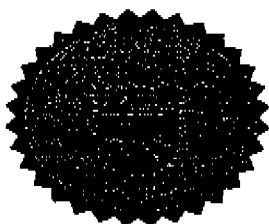
