ASSIGNMENT

WHEREAS, Christopher E. Fischer and Domenico further hereby assign and agree to assign to Boomerang the entire right, title and interest, domestic and foreign, which Fischer and Domenico may have in any discoveries, improvements and inventions made, conceived or developed by Fischer and Domenico in connection with the development of said invention and do further agree to execute all applications for patent, assignments and other appropriate documents and to perform all things necessary to make this Assignment effective and to perfect all right, title and interest in and to said discoveries, improvements or inventions in said Boomerang. Boomerang hereby acknowledges and accepts the assignment and agreement to assign the same.

Fischer and Domenico hereby authorize and request the law offices of Timothy J. Martin, P.C., to insert here in parentheses (Application number 10/780,122, filed February 17, 2004.) the filing date and application number of said application when known.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment to Boomerang, its successors, legal representatives and assigns of the entire right, title and interest therein.



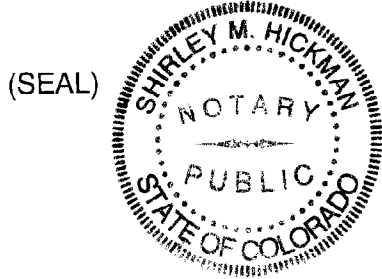
