AND We do hereby authorize and request the United States Commissioner of Patents and Trademarks to issue said United States Letters Patents to said assignee, as the assignee of our entire right, title, and interest therein.

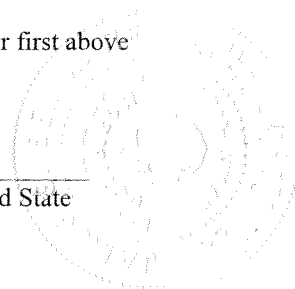


