AND WE FURTHER covenant and agree, in consideration of the premises, that we or our executors and administrators, will at any time upon request communicate to the said Sulzer Chemtech AG, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to us or to our executors and administrators, and that we will testify as to the same in any interference or other litigation when requested so to do by the said Sulzer Chemtech AG, it being understood that, Sulzer Chemtech AG will compensate us for our expenses reasonably incurred in complying with its requests.
