

AND I HEREBY further covenant and agree that I will communicate to said FLEETWOOD ENTERPRISES, INC., its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid said FLEETWOOD ENTERPRISES, INC., its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
