

any agreement in conflict herewith.

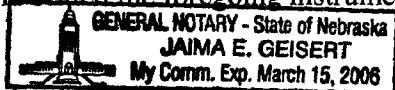
