

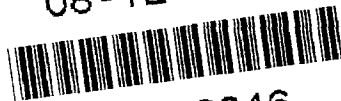

ASSIGNMENT

International Machine Design, LLC, a Massachusetts limited liability company, having its principal place of business at 107 River Pointe Way, Lawrence, Massachusetts 01843 ("Assignor"), in consideration of \$105,000.00, and other good and sufficient considerations, the receipt of which is hereby acknowledged, by these presents has sold, assigned, transferred and set over, and by these presents sells, assigns, transfers and sets over unto International Isotopes Inc., a Texas corporation with its principal place of business at 4137 Commerce Circle, Idaho Falls, Idaho 83401, as assignee, and its successors, assigns and legal representatives, effective at least as early as January 30, 2004, Assignor's entire right, title and interest, for all countries, in and to the invention described in the following Letters Patent granted by the United States Patent and Trademark Office:

- (1) Patent No. 5,888,468 Silicon tetrafluoride from Uranium tetrafluoride
- (2) Patent No. 5,901,338 Uranium Oxide from UF₄, Silicon & Gaseous oxide
- (3) Patent No. 5,918,106 Uranium Oxide & F1 compound from UF₄ and Solid Oxide
- (4) Patent No. 6,033,642 Silicon tetrafluoride from Uranium oxyfluoride
- (5) Patent No. 6,086,836 Uranium Oxide from Uranium Oxyfluoride Silicon
- (6) Patent No. 6,096,281 Uranium Oxide from Uranium oxyfluoride
- (7) Patent No. 6,153,164 Uranium Oxide from UF₄ and Phyllosilicate Mineral

and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said Letters Patent under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any Official of any country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of industrial property on applications as aforesaid to issue the same to International Isotopes Inc., its successors, assigns and legal representatives, or to such nominees as it may designate.

Assignor agrees that, when requested, it will, without charge to International Isotopes Inc. but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for the inventions in any and all countries and for vesting title thereto in International Isotopes Inc., its successors, assigns and legal representatives or nominees.

Assignor authorizes and empowers International Isotopes Inc., its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for the inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable, and to invoke and claim such right of priority without further written or oral authorization from Assignor.

Assignor hereby consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the assignee or nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

Assignor covenants with International Isotopes Inc., its successors, assigns and legal representatives or nominees that the rights and property herein conveyed are free and clear of any encumbrance, and that Assignor has full right to convey the same as herein expressed.

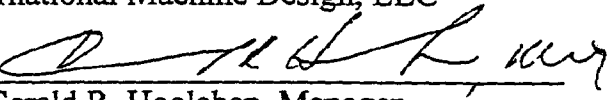
Seller warrants that it has good, valid and marketable title to the Purchased Assets, free and clear of any lien or encumbrance, except as otherwise provided in the Agreement.

IN WITNESS WHEREOF, Seller has caused its duly authorized representative to execute this Bill of Sale as of this 21st day of January, 2004.

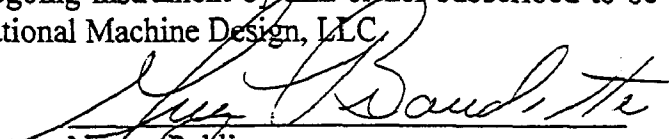
