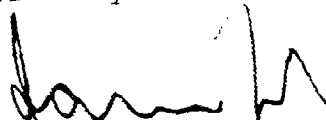
The change of name became effective upon its registration in the Commercial Register at Düsseldorf No. HRB 44880 on November 19, 2002.

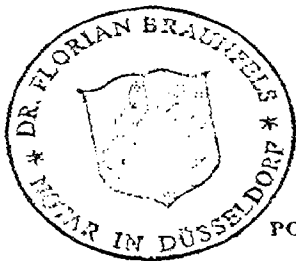
