(1) ASSIGNOR, has sold, assigned, transferred and set over and does hereby sell, assign, transfer and set over to the said ASSIGNEE, ASSIGNOR's entire right, title and interest in the said inventions, patent applications and LETTERS PATENT, and to any and all subsequent applications claiming priority through the LETTERS PATENT and to any and all reissues or reexamination certificates of said LETTERS PATENT, including the subject matter of any and all claims which may be obtained in every such patent, the same to be held and enjoyed by the said ASSIGNEE for its own use and behoof, and for the use and behoof of its successors, assigns, or other legal representatives, to the end of the term or terms for which said LETTERS PATENT of the United States, territories and any foreign countries are or may be granted, reissued, or reexamined as fully and entirely as same would have been held and enjoyed by ASSIGNOR, if this assignment and sale had not been made.

(2) ASSIGNOR has sold, assigned, transferred and set over and does hereby sell, assign, transfer and set over to the said ASSIGNEE, ASSIGNOR's entire right, title and interest in the TECHNOLOGY RIGHTS.

(3) ASSIGNOR further hereby covenants and agrees that he will, at any time, upon request, at the expense of said ASSIGNEE, execute and delivery any and all papers that may be

necessary or desirable to perfect the interest to said inventions, and to said LETTERS PATENT as may be granted therefor, in said ASSIGNEE, its successors, assigns, or other legal representatives.

(3) This Assignment is made by Assignor pursuant to the Authority of that certain Order of the United States Bankruptcy Court dated October 29, 2003, and pursuant to this Assignment, Assignor conveys all right, title and interest in the invention, patent applications, TECHNOLOGY RIGHTS and LETTERS PATENT listed above, and any and all reissues or reexamination certificates of said LETTERS PATENT, including the subject matter of any and all claims which may be obtained in every such patent free and clear of any lien, claim or encumbrance of any third party, but otherwise this Assignment and Bill of Sale is WITHOUT WARRANTY.


