**TERMINATION AND RELEASE
OF SECURITY INTEREST IN PATENTS**

This Termination and Release of Security Interest in Patents is granted as of this 4 day of February, 2005, by COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A. trading as RABOBANK INTERNATIONAL, LONDON BRANCH, having a principal address at Thames Court, One Queenhithe, London, England EC4V 3RL ("Rabobank"), as agent and trustee ("Security Agent") for, and for the benefit of, itself and each of the Lenders, as that term is defined in the Debenture (collectively, the "Secured Finance Parties") in favor of TETLEY GB LIMITED, a company incorporated under the laws of England, with an office at 325-347 Oldfield Lane North, Greenford, Middlesex UB6 0AZ England ("Tetley GB"). All capitalized terms not defined herein shall have the meaning set forth in the Debenture dated as of February 28, 2003 between Tata Tea (GB) Limited and Rabobank, as Security Agent ("Debenture").


WHEREAS, pursuant to a certain Collateral Assignment of Patents dated February 28, 2003 ("Collateral Assignment"), Tetley GB granted Rabobank, as Security Agent for the Secured Finance Parties, a security interest in the Collateral (as defined in the Collateral Assignment), including all U.S. patents and patent applications for the protection of inventions or designs listed on Schedule A attached hereto, and recorded such security interest in the Collateral with the United States Patent and Trademark Office on March 7, 2003 at Reel 013804, Frame 0387;

WHEREAS, Tetley GB also executed a certain Senior Facility Agreement among Security Agent, the Secured Finance Parties and certain of Tetley GB's affiliates ("Facility Agreement") pursuant to which Tetley GB became a Guarantor (as defined therein) to the Facility Agreement and an Obligor (as defined therein) to the Priority Agreement to the Facility Agreement; and

WHEREAS, as the Secured Liabilities have been paid in full in a timely manner, the Parties are desirous of recording this instrument to confirm and evidence termination and release of the security interests of Rabobank, as Security Agent for the Secured Finance Parties, in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge, Rabobank, as Security Agent for, and on behalf of, the Secured Finance Parties, hereby (1) terminates, releases, discharges, and relinquishes all security interests in, to and under the Collateral, and (2) re-assigns to Tetley GB all of its right, title and interest in, to and under the Collateral granted to Rabobank, as the Security Agent for the Secured Finance Parties, under the Collateral Assignment, including the right to sue for past, present and future infringement of the Patents and Future Patents (each as defined in the Collateral Assignment).
