ASSIGNMENT OF PATENT APPLICATION

WHEREAS, We, Robert G. Younge and Daniel T. Wallace, citizens of United States of America (hereinafter referred to as "ASSIGNORS"), have invented and own a certain invention entitled **SYSTEM AND METHOD FOR 3-D IMAGING** for which application for Letters Patent of the United States of America has been filed with the United States Patent and Trademark Office on August 20, 2004, under Serial No. **10/923,660**; and

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;




