**ASSIGNMENT**

WHEREAS, **Luciano Rossetti** and **Silvana Obici** (hereinafter "the Assignors"), both citizens of Italy, and residing at, respectively, 4 Sherwood Lane, Bedford Hills, New York 10507; and 926 Vincent Avenue, Bronx, New York 10465, have invented certain new and useful improvements in **REGULATION OF FOOD INTAKE AND GLUCOSE PRODUCTION BY MODULATION OF LONG-CHAIN FATTY ACL-CoA LEVELS IN THE HYPOTHALAMUS**, for which a PCT Patent Application No. PCT/US2004/004344 was filed with an international filing date of February 12, 2004; and

Assignors further covenant to execute all additional instruments, and to do all things necessary to carry out the purpose of this instrument, at the expense of the Assignee and its successors.


